

## Certified Food Management Training Opportunities

Effective April 2, 2010, Michigan food service establishments must have at least one certified food service manager on staff. This Person-in-Charge or "PIC" must pass an exam through an accredited program recognized by the Michigan Department of Agriculture (MDA).
